Invitation to Discuss Creating a Science Shop Association of the Americas (SSAA)

Peter Levesque, Ottawa, Canada, has launched the initial consultations leading to the creation of a Science Shop Association of the Americas and is seeking input from interested parties from across Central America and the Caribbean, North America, and South America. He is also seeking support and ideas from colleagues around the world, currently active in Science Shops, Community-based Research Centres, and Participatory Action Research initiatives, on how best to create and support such an Association.

Given the growing policy strength of the Science Shops in the European Community, the mass of funded initiatives in Canada and the United States, the long history of Participatory Action Research in Latin America and South Asia, the timing appears right to push on creating a more public profile for such activities in the Americas, with a focus on the Americas.

There are 35 independent countries and 16 dependencies, colonies or territories in the Americas, divided into three large groupings: Central America and the Caribbean, North America, and South America. All of these, with the exception of the Falkland Islands (Islas Malvinas), and Navassa Island are served by colleges, universities, and/or incorporated community organizations. As is the case in Canada, there is community-based research / participatory action research / Science Shop activity currently underway which could benefit from the creation of an association or community of practice.

Although new initiatives are needed and welcome, there is definitely value to be derived from an ongoing exchange between existing entities. This has been clearly demonstrated in the creation of the International Science Shop Network and Living Knowledge. The sharing of



knowledge, opportunities, and expertise increases the value of that knowledge by creating new contextual interpretations. An Association can reduce the time and cost of this exchange by helping to identify patterns and brokering relationships between actors. It can also serve to protect knowledge and practice that is at risk of being lost or assimilated by larger, more powerful forces. Initial thoughts include the possibility that many communities across the Americas could benefit greatly from the creation of Science Shops directly or in association with existing Science Shops. The work of Dr. Henk Mulder of the University of Groningen (Netherlands) with his colleagues in Romania is a good example.

Hemispheric bodies however, are not created without much discussion, many alliances, plenty of resources, lots of thinking, and a great amount of political will. Creating the Science Shop Association of the Americas, linking activities from Nunavut to Tierra del Fuego, should start with identifying clusters of current activities and drawing these clusters together - CURAs, CBR Centers, public research groups. Linkage without productive activity however, will quickly cause dissipation of collective intentions and efforts. As such, it is important that roads be created to opportunities that derive value - new resources, new personnel, new ideas, new contexts.

This call to interested individuals, whether singular or in associations, is being made in order to develop an understanding of what the creation of the SSAA will mean to public science in the Western Hemisphere. Among the many initial supporters of this idea are Richard Sclove, founder of the Loka Institute and author of "Democracy and Technology" (Amherst, MA, USA), Caspar de Bok, head of the Biology Science Shop at the University of Utrecht, (Netherlands), and co-ordator of Living Knowledge – The International Science Shop Network, and Bessa Whitmore, Professor of Social Work, Carleton University, Ottawa and co-founder of the Community-based Research Network of Ottawa (Canada).

Work programme 'Science and Society 2004' - Submitted proposals

(Governance, scientific advice, outreach and communication, FP6-2003-Science-and-Society-7)

For the work programme 'Science and Society 2004' with the closing date of 11 May 2004 the following proposals involving Science Shops have been submitted:

TRAMS

TRAMS (Training and Mentoring of Science Shops) will develop specific structural services for the International Science Shop Network Living Knowledge. The EC project ISSNET shows there is a growing request for tools and support to get started with new science shop activities in many regions of Europe. Development and dissemination of innovative practice in science shops will be encouraged, through a customised training programme toolbox and appropriate partnering and exchange (mentoring) among members of Living Knowledge. All members of Living Knowledge can participate in activities of TRAMS (e.g. workshops) and make use of the results and materials of TRAMS. The workpackages of TRAMS will focus on 1) Mentoring, 2) Training materials, 3) E-modules, 4) Dissemination of results. Co-operating Science Shops and Science Shop like organisations come from Austria, Belgium, Denmark, France, Germany, Greece, Iceland, the Netherlands, Romania, Spain, Turkey and the United Kingdom.

FUSSNEWS

"Future tasks of the International Science Shop Network and its added value for intermediaries and their clients with respect to New Member and Candidate States of the EU (FUSSNEWS)" intends to encourage and to enable the participants and their partner organisations to improve the work of their already existing intermediaries or to establish new ones promoting Community Based Research and citizen oriented knowledge transfer. Tasks and structures of intermediaries will be reflected in relation to gender issues. Furthermore the specific situation of the science-society dialogue within the transformation process of former socialist countries will be explored. Applicants: 10 Science Shops and Gender Units from Austria, Bulgaria, Czech Republic, Estonia, Germany, Slovakia, Spain, and Turkey.

CIPAST

The CIPAST (Citizen Participation in Science and Technology) proposal aims at bringing together organisations (1) having significant experiences in the use of participatory procedures in scientific and technological issues, (2) belonging to the different families of experienced actors in that field (parliamentary offices, research institutes, science shops and science museums, academic researchers), (3) already structured in European networks (EPTA, IGLO, ECSITE, ISSNET). These organisations will be mobilized for setting up a training programme and producing re-usable training tools tailored to the various contexts in which participation of civil society is relevant. The target audience for this training programme will be decision-makers belonging not only to the political sphere, but also to research sector, non profit organizations and industry; a special effort will be made to identify participants in the new member states of the E.U. Co-operating organizations from Denmark, France, Germany, Italy, the Netherlands, Switzerland and the United Kingdom

This summer the EC will start discussions - mainly internal - about the Science and Society Work Programme 2005 and 2006. At a workshop on Science Shops during the conference 'The Europe of Knowledge 2020' in Liège last month the question was raised what the EC can do to support the networking of science shops, what EC activities will be beneficial for the science shop network and how the EC can improve the involvement of community groups in the use of knowledge and the debate on science and society. These open questions give opportunity to contribute to the discussion on the new Science and Society work programme.

The Living Knowledge Discussion List can be used to raise topics and questions which might be relevant for the coming work programme. The network can be used to share and discuss ideas. The chance of this informal procedure is to give input to the EC. The International Science Shop Office will collect all information and summarise it before informing the EC about the ideas that are going around in the network.

Advancing in Science & Society Interactions, 2nd Living Knowledge conference, Seville (Spain)

Conference Focus: Learning from community based approaches to research.

This conference deals with the relation between citizenship and science and technology; specially with community based research and on research done by civil society actors. The Event of Seville, 3-5 February 2005, is the second international Conference promoted by the Network "Living Knowledge" and will be dedicated to present, to debate and to evaluate the experiences, future trends and opportunities of Science Shops and similar organizations. Science Shops are mediating organizations that promote and facilitate Universities to open to their local communities with the collaboration of university students and NGO's or civic associations.

- · Social Demands on Research and Technology.
- Structures for the science and society mediation.
- Science Dissemination and Communication.
- Society's participation in science.

The Conference is hosted by the University of Sevilla and is organized in plenary sessions, panel sessions, parallel sessions with paper presentations; video sessions; and market place for the presentation of posters and exhibits. The conference is sponsored by the European Commission (within the ISSNET project) and the Social Council of the University of Seville.
